ORDER

WHEREAS, the recognition was granted to the institution namely, **Koolippulakkal Pathummakutty Memorial College of Teacher Education, XII/ Room 2, Pandi Palace Building, Manjeri Road, Up Hill, Malappuram- 676505, Kerala** vide SRC (NCTE) order No.**F.KL/SE/N/20/SRO/NCTE/2002-2003/2316** dated **05/08/2002** for conducting **B.Ed.** course of one-year duration with an annual intake of 130 students from the academic session 2002-2003.

AND WHEREAS, after promulgation of NCTE Regulations, 2014, the institution had submitted affidavit dated **29/01/2015** for its willingness for adherence of provisions of new Regulations.

AND WHEREAS, a Revised Provisional Recognition Order (RPRO) was issued to the institution on **15/05/2015** for conducting **B.Ed.** course of two years duration with an annual intake of 100 students (two basic units of 50 students each) from the academic session 2015-2016 subject to submission of revalidated FDRs of the enhanced value in joint account with the SRC before 30 June, 2015 and fulfillment of the conditions mentioned at II & III herein before 31.10.2015.

AND WHEREAS, the SRC issued a Corrigendum vide order dated **15/07/2015** permitting the institution to have **one basic unit of 50 students** from the academic session 2015-2016.

AND WHEREAS, the SRC in its 369th meeting held on 28.01.2019 decided that Show Cause Notice be issued to all such institutions which have not submitted compliance. Accordingly, as per the decision of SRC, a show cause notice was issued to the institution on **04/10/2019**. In response, the institution submitted its written representation on **13/11/2019**.

AND WHEREAS, the matter was further considered by the SRC in its 383rd Meeting held on January 7-9, 2020 and the Committee decided as follows:-

"The original files of the Institution along with other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

The Institution was issued a Show Cause Notice (SCN) on 04.10.2019. The institution has not submitted any reply / written representation against the Show Cause Notice issued. Hence, the Committee decided to issue Final Show Cause Notice to the institution to submit the following documents:-

- 1. The institution is required to submit certified copy of land documents issued by concerned Tehsildar /Revenue Officer. (If the same are in Regional Language the institution is also required to submit notarised copy of English version of land documents)*

AND WHEREAS, the SRC in its 384th meeting held during February 12-13, 2020 considered the matter and decided as under: -

"The original files of the Institution along with other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

On the perusal of the reply, documents and records submitted by the Institution, Committee also decided that the continuation order be issued to the Institution Koolippulakkai Pathummakutty Memorial College of Teacher Education, Malappuram – 676505, Kerala for B.Ed programme for 1 basic unit of 50 students".

NOW THEREFORE, this order is issued permitting the institution **i.e. KOOLIPPULAKKAI PATHUMMAKUTTY MEMORIAL COLLEGE OF TEACHER EDUCATION, XII/ROOM 2, PANDI PALACE BUILDING, MANJERI ROAD, UP HILL, MALAPPURAM – 676505, KERALA RUN BY KOOLIPULAKKAL PATHUMMAKUTTY MEMORIAL TRUST, XII/ROOM 2, PANDI PALACE BUILDING, MANJERI ROAD, UP HILL, MALAPPURAM – 676505, KERALA** for continuation of recognition for B.Ed. course of two years duration with an annual intake of **50 students (one basic unit)** subject to fulfillment of the following conditions:-

- I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
- II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
- III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.

Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc as applicable.

The institution shall submit to the Regional Committee as Self – Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.

The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter – alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. 2. The institution is required to submit an attested/notarised copy of Land Use Certificate issued by the Competent Authority. The institution is required to submit an attested/notarised copy of Non - Encumbrance Certificate issued by the Competent Authority.
3. The institution is required to submit an attested/notarised copy of the approved Building Plan (if institution is running more than one Teacher Education programme, it shall be required to submit an exclusive earmarked building plan for each of the recognised Teacher Education programme)
4. An attested/notarised copy of site plan showing all the plot/Survey No. mentioned in the land documents in one location along with land area and built up area.
5. The Institution is required to submit an attested/notarised copy of Building Completion Certificate issued by the competent authority.
6. The institution is required to submit Staff list duly approved by the Registrar of the affiliating body as per the prescribed Format. (In case the institution is running more than one teacher education programme, it is required to submit staff list duly approved by the Affiliating body for each of the recognised teacher education programme being run by the Institution.)
7. The institution is required to submit a "Form A" issued by the respective Bank Manger towards creation of FDR of Rs.7 lakh and 5 lakh, totalling Rs.12 lakh towards Endowment Fund & Reserve Fund into joint account for a duration of 5 years along with a copy of the FDRs

The institution shall make available the list of students admitted on its official website.

The institution shall fill the information on GIS Portal on the NCTE Website. If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made or issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provision of Section 17(1) of the NCTE Act, 1993. Also order that a copy of this Order be published in the official Gazette.
